Installation:

The prosthetic products covered in this manual are equipped with a one half inch diameter threaded stud. They will simply screw into a prosthesis or can be fitted with an adapter sleeve for disconnect style prosthetic wrists.

These products do not require the use of a cable. If a cable is present on the prosthesis, it can be taped to the forearm section of the prosthesis or secured in place with an elastic cuff. Securing the cable could aid in prosthetic suspension, improve safety or just prevent the cable from interfering with movement and activities.

The products are positioned on the prosthesis so that the volar (palm) surface faces the body's midline. This will be the optimal position for use.. Experiment with other positions to determine how they impact your performance.

Training/Education Information:

The Super Sport, Free Flex, Infant 2 and the ReBound products are simple but highly functional prosthetic devices. They are flexible, durable and easy to use. Their primary functions include providing opposition and control for bimanual activities, storing energy and providing a safe, flexible interface at the end of the prosthesis. The Super Sport, Free Flex and ReBound accessories have been successfully used in sports like basketball, volleyball, football and soccer where interpersonal contact is likely, as well as other types of activities, such as tumbling, dance, floor exercise, jogging, in-line skating, etc.

No formal training regime exists. Consult with a registered Occupational Therapist (OTR) or a Registered Physical therapist (RPT) with specific experience in upper extremity prosthetics for specialized help, muscle reconditioning, strength building, etc.

TRS produces a sports and recreation DVD Video entitled "Upper Extremity Prosthetics for Sports and Recreation" that could be useful in helping to understand the uses of these types of products.

Care and Cleaning

These products are constructed of various polyurethane compounds. Polyurethane is tough, abrasion and chemical resistant. It resists dirt and stains but permanent dyes will discolor the material.

Cleaning these products after each use is recommended ... just like washing your hands. Use dish washing detergent and a sponge or brush. Powdered chlorine type cleansers work well for discolorations and stains. Steel wool soap pads like Brillo[®] can also be used. They are abrasive and will help get out surface dirt and stains. Permanent ink stains like permanent marker must be removed immediately or the dye will penetrate into the material and will not be able to be removed. Try an appropriate solvent then wash with soap and water.

Custom Modifications

The Super Sports and Free Flex products are composed of a solid polymer. It is possible to increase their flexibility by removing material in specific areas. Removing material at flexion areas will increase flexibility.



CAUTION! Removing material from these devices compromises the polyurethane rubber surface.

Once altered, the surface stains easier. Grinding on the back or superior side of the product is recommended, not the volar or palm surface. Buff the ground surface to be as smooth as possible. Fine sandpaper will work to finish the surface. Do not use steel wool to buff the surface! Wash the product thoroughly after modification. Modifying these products in this manner permanently alters them. Products modified cannot be returned to TRS.
